OVERALL, THE ENTERPRISE DISTRIBUTED OVER 1.126 MILLION EYEGASSES IN 23 MARKETS OF WHICH 796K PAIRS WERE CORRECTIVE AND 330K WERE PROTECTIVE . THIS REPRESENTS A 25% GROWTH RATE IN CORRECTIVE PAIRS OVER 2015, AND 76% GROWTH OVER 2014.
